Be sure that your dog meets the following requirements. The dog must have completed a beginner obedience class. INTERMEDIATE: Dog must know how to complete all agility obstacles. ADVANCED: Dog must have a qualifying score in Novice level competition. Courses used in practice will be Master level courses.

First priority for signup goes to DOTC members (register now through May 9);

Second priority will be nonmembers who train obedience with DOTC (You may send your applications in now.

Applications on file will be accepted on May 10 in the order they were received);

then to those with no affiliation if space permits (starting May 24).

Class size is limited to 15. There is a limit of one dog per handler unless class does not fill.

To apply for the class, please complete the attached application form and sign your name to the release at the bottom. Mail your application with payment and a copy of **proof of RABIES and DHLPP** (shot records) to Judy at 2575 Hawkins Mill Rd, Lynchburg VA 24503-4968. Dogs who were enrolled in advanced obedience classes may have current shot records on file with Judy. You will be notified when your application is accepted. Your payment will be returned if the class has filled.

Directions:

From Rt 221, turn on Rt 621 Cottontown Rd at CVS. Go one mile and bear right as name changes to Rt 660, Hawkins Mill Road. House is about 1.25 miles further, on the right.

From Coffee Rd, turn onto Hawkins Mill at the Randolph College Riding Stables. We are about 2 miles from the stables, on the left.

From Wiggington Rd at the stables, turn left for about 2 miles. House is on the left.

Classes will be outdoors and will be held unless there is a heavy rain or lightning. Come prepared to work in light rain if necessary.

I certify and represent that the dog entered is not a hazard to persons or other dogs. The Dog Owners Training Club of Lynchburg, Inc. has the right to refuse to have this dog in the training class for cause which the club shall deem to be sufficient.

I agree to hold the Dog Owners Training Club of Lynchburg, Inc., its members, directors, officers, agents, instructors and owners of premises upon which the event is held, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the Agility Training premises or grounds of or near any entrance thereto, and I personally assume all responsibility and liability for any such claim; and I further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself, or on account of damage to property, arising out of or in consequence of my participation in this Agility Training, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may alleged to have been caused by negligence of the aforementioned parties or any of the employees or agents, or any other persons.

I assume sole responsibility for and agree to pay all expenses for repair of property damaged by myself or by my dog while on the training premises, or for veterinary care for any damage caused by myself or by my dog to cats or dogs belonging to the Smotrels.

Dogs will be kept on leash at all times except when required to be off lead in training or when running the agility course.
